Bal-A-Vis-X provides assistance to children, adults and the elderly, to promote learning of physical, educational and social skills. Improve self-esteem and self-confidence.

The Bal-A-Vis-X method can benefit people who are affected by:

Dyslexia, Different forms of autism (eg Asperger, etc), Dyspraxia, Hearing disorders, Dyscalculia, Linguistic competence, Developmental delay, Disorder from Attention deficit with or without hyperactivity (TDA / H), Memory disorder, Parkinson's disease, Alzheimer's disease, people who are blind or whose visual acuity is decreased.

This program helps to recover faster after a stroke, improves fine and general motor skills, as well as coordination skills ...

Program:

- 1st day: level 1, learning the basic principles, models, rhythms, procedures and the first 125 exercises .
- 2nd day: level 2, multiple variations of level 1 exercises and learning of 50 more complex exercises.
 - Bal-A-Vis-X Apprenticeship adapted to the public in difficulty: multiple changes in the exercises and models of levels 1 and 2, as well as learning exercises for children of preschool age, for the elderly and for people with more serious problems.
- 3rd day: level 3, advanced exercises and more complex variations of levels 1 and 2.
